Agreement between the Vermont Sheep & Wool Festival (VSWF) and _____
for the period Sept 30 and Oct 1, 2017. By signing this letter of agreement, the organization consents to the following conditions:

- Organizations should be fiber or farm related. The Festival Committee reserves the right to reject an applicant for lack of suitability and compatibility.
- Will provide VSWF a Certificate of Liability Insurance, in the amount of no less than \$1,000,000.00, naming the Vermont Sheep & Wool Festival and the Union Agriculture Society (UAS) dba Tunbridge World's Fair, for the period Sept 30 and Oct 1, 2017. Certificate must be received by Sept. 1, 2017.
- Checks payable to the "Vermont Sheep & Wool Festival" shall be included with this application.
- Will be set-up by 9:00 am, and remain open and staffed during the Festival hours (no early closings!):
Saturday, Sept 1 from 10 am to 5 pm, and Sunday October 1 from 10 am to 4 pm
- Will remove all structures and equipment from the grounds no later than 7 pm, Sunday, October 1, 2017.
- Will not sublet any part of the contracted space without written permission of the VSWF.
- Will not hold the VSWF or the UAS responsible for lost or stolen merchandise, damage to property, or other loss incurred as a result of contracting for the above space. Furthermore, the organization agrees to file no claim against VSWF or UAS for any medical, dental, hospital, or other expenses incurred as a result of an accident in the above space.
- Booth must be manned at all times.
- Non-profit groups may sell memberships and take donations. Merchandise sales are not allowed.

The Vermont Sheep & Wool Festival will provide four admission passes/per organization for the weekend; two for each day.

Neither the Vermont Sheep & Wool Festival nor the organization will be liable for failure to meet any requirements of this contract when such failure is due to fire, flood, or other causes beyond the control of the VSWF, UAS, and the organization.
